Executive Summary

1. Introduction

The Program Year 2021 Annual Action Plan has been completed in compliance with Federal regulations and through consultation with stakeholders and program staff. A variety of projects have been identified throughout the plan, which are intended to assist in the provision of housing, community development, assistance for individuals and families experiencing homelessness, and neighborhood revitalization. These projects are being undertaken in accordance with the objectives, outcomes, and goals specified in Lee County's 2019-2023 Consolidated Plan.

2. Summarize the objectives and outcomes identified in the Plan

Goals include the provision of housing rehabilitation, down payment assistance, increased economic opportunities, homeless housing and services, development of CHDO and Non-CHDO housing, and revitalization of neighborhoods. These goals will be met through a number of projects, and subsequently, a number of activities within each project. 3. Evaluation of past performance

This is an evaluation of past performance that helped lead the grantee to choose its goals or projects.

The Covid-19 pandemic has created additional needs in Lee County. Higher need for rental assistance, economic support, and health and safety measures have been identified throughout the community. At the start of the Covid-19 pandemic, the Southwest Florida Community Foundation administered multiple flash polls to gather data regarding community impact. The April-May 2020 poll revealed that assistance paying bills, access to food, and wellness services (including physical and behavioral health)

were the greatest needs. As the pandemic continued the need for affordable housing has increased, as has the need to provide re-housing assistance for persons experiencing homelessness, and expanded behavioral health services.

In addition to needs resulting from the Covid-19 pandemic, other community needs were identified through a gaps analysis that was completed for Lee County in 2019. The three dominant gaps identified were in the areas of behavioral health, housing and transportation. Based on these findings and the need created through the COVID-19 pandemic, additional funding has been allocated to rapid rehousing program, down payment assistance, and non-profit capital improvements.

Staff and others consulted during the planning process evaluated past project outcomes. Through this consultation, it was determined that the continuation of most of the previous year's projects was necessary. In addition, staff and the public recommended that affordable housing be a high priority in this plan. Projects such HOME Non-CHDO housing development and HOME Down Payment Assistance are being allocated additional funds in this plan to facilitate the provision of additional affordable housing units. The allocation for CDBG Non-Profit Capital Improvement is being increased to support the needs of non-profit service providers.

4. Summary of Citizen Participation Process and consultation process

Citizens are encouraged to participate in a variety of avenues. Lee County welcomes input during two dedicated public meetings. The draft plan is published on the Lee County website, and public notice to review the plan is published in the Newspress with contact information for county employees. The public is encouraged to comment throughout the consultation process.

5. Summary of public comments

Public input received during the January 14, 2021 public meeting, which included a focused discussion around affordable housing. Input was received advocating for youth services, such as child-care assistance, job training, educational and after school programs. Additional input mentioned the need for behavioral health services and how these needs are tied to affordable, permanent housing.

Comments received during the March 11, 2021 public meeting included discussion regarding the availability and functionality of public transportation, specifically bus routes. Suggestions for economic development included supporting and encouraging small businesses. The issue of a lack of affordable housing was discussed, as well as potential development of low-income rental units. There was input

regarding the need for job training among various populations, including expanded certification and credentialing programs and youth mentorship programs.

Lee County Human and Veteran Services (HVS) is responsible for preparing the Consolidated Plan. Lee County's entitlement consists of Community Development Block Grant (CDBG), HOME Investment Partnership Program (HOME), and Emergency Solutions Grant (ESG) programs, all of which are administered by HVS managers in several departmental program areas, with clerical and fiscal support. Sub-recipient contracts with Urban County and nonprofit agencies are monitored by HVS, but fieldwork is completed by City of Bonita Springs, Village of Estero, City of Sanibel or nonprofit agency staff.

1. Introduction

Provide a concise summary of the jurisdiction's activities to enhance coordination between public and assisted housing providers and private and governmental health, mental health and service agencies (91.215(I))

Coordination between public and assisted housing providers and private and governmental health, mental health and service agencies occurs on a regular basis to provide coordinated client services, and for the development of this plan. The Bob-Janes Triage Center and Low-Demand Shelter continues to provide an example of this community-wide coordination. The Triage facility is jointly funded and managed by Lee County Human and Veteran Services, the Salvation Army, and SalusCare, and partners with local law enforcement and homeless service providers. Staff from local non-profit service providers, Lee Health, law enforcement agencies, and public housing agencies regularly meet and carry out efforts to address community needs, such as the assisted implementation of the CoC's 2019-2028 Strategic Plan.

In 2020, Lee County Human and Veteran Services identified the need for increased capacity in Street Outreach and Coordinated Entry. Community Development Block Grant and Emergency Solutions Grant funds were used to support creation and implementation of outreach teams in partnership with six local law enforcement organizations, and Centerstone, a local behavioral health provider. These teams were deemed the Housing, Outreach and Treatment (HOT) teams to signify their intent within the CoC. This partnership expanded outreach capacity throughout Lee County area. To improve services available after regular business hours, Lee County Human and Veteran Services also contracts with Center for Progress and Excellence, the local operator of the Mobile Crisis Unit, to offer 24/7/365 access to the CoC's Coordinated Entry process.

Describe coordination with the Continuum of Care and efforts to address the needs of homeless persons (particularly chronically homeless individuals and families, families with children, veterans, and unaccompanied youth) and persons at risk of homelessness.

Lee County Human and Veteran Services is the Lead Agency for the Continuum of Care, and has spearheaded the local effort to ensure compliance with the HEARTH Act provisions. There is continuous coordination between Lee County, the Lee County Homeless Coalition, and the Continuum as a whole, to address the needs of persons who are homeless or at risk of homelessness. This includes discharge planning, identifying needs and gaps in the community, evaluating system and project performance, establishing system-wide written standards, and researching project models and funding sources.

Lee County Human and Veteran Services is leading continuous efforts for rapidly re-housing persons who are experiencing homelessness. Most recently HVS spearheaded a 100x100 housing campaign

aimed at housing 100 households in 100 days. The Continuum of Care exceed that goal by housing 124 households, and have begun another campaign during which the CoC is expected to far exceed the 100 household goal. The County continues allocate more than \$1.8 million in HUD Continuum of Care funds to provide rapid re-housing assistance to families with children. Remaining Continuum of Care funds are allocated for Permanent Supportive Housing projects, which are prioritized for individuals who are chronically homeless. State Emergency Solutions Grants, Temporary Assistance for Needy Families - Prevention, and Challenge grants funds are used to provide homelessness prevention assistance for persons at risk of homelessness.

Describe consultation with the Continuum(s) of Care that serves the jurisdiction's area in determining how to allocate ESG funds, develop performance standards for and evaluate outcomes of projects and activities assisted by ESG funds, and develop funding, policies and procedures for the operation and administration of HMIS

As previously noted, Lee County is the Lead Agency for the Continuum of Care, and is in continuous consultation with the Continuum Governing Board and General Membership, including consulting on ESG Planning. Continuum members continue to support the current ESG program structure, in which Human and Veteran Services administers a portion of the ESG allocation to provide outreach and rapid re-housing assistance to eligible households and allocates remaining funds for shelter operations.

In 2017, the Continuum of Care Governing Board established new project performance targets and approved continuum-wide written standards. In September 2019, the Board approved the transition to a single point of entry model for Coordinated Entry, in accordance with CPD Notice 17-01. ESG projects are monitored annually, and outcomes are included in system performance measures. The Lee County Continuum of Care Governing Board was consulted during their June 2021 meeting. During the meeting, Board members supported the continuation of the Rapid Re-Housing programs administered by Human and Veteran Services and the Salvation Army at the Bob Janes Triage Center.

1. Summary of citizen participation process/Efforts made to broaden citizen participation Summarize citizen participation process and how it impacted goal-setting

Lee County hosted two public hearings, and published this plan for public comment in a locally circulating newspaper. Feedback received at public hearings focused largely on housing and homelessness, youth services, and transportation. Multiple groups stressed the issues created by a lack of affordable housing and potential solutions including down payment assistance, additional workforce housing availability and creative housing solutions. The question of best practices to assist individuals who are homeless in Lee County was discussed often. Lack of affordable, reliable transportation was discussed, as well as a lack of bus stops in specific areas that would be beneficial. Feedback was received relating to the need for behavioral health services and the relation to permanent housing. Finally, programs for youth and young adults in the areas of education, job training, child-care assistance and supportive after school programs.

Services provides are funded with Lee County General funds, Continuum of Care programs, HOPWA and CSBG. Additionally, State SHIP funds are used to assist low-income persons with down payment assistance, and provide match for HOME funded projects. ESG will be matched with County General funds, as well as other resources documented by sub-recipients. Some CDBG funds will be concentrated on neighborhood revitalization, and will be used in the targeted areas noted in this Consolidated Plan. These funds will be leveraged with private funds gathered by neighborhood organizations through fundraising.

AP-60 Public Housing – 91.220(h)

Introduction

Lee County has two housing authorities. The Housing Authority of the City of Fort Myers (HACFM) and the Lee County Housing Authority (LCHA). Both housing authorities were consulted and collaborate annual to meet the needs of Lee County residents.

Actions planned during the next year to address the needs to public housing

Lee County Housing Authority is planning to convert Public Housing stock to tenant-based assistance, if it is deemed feasible. Further analysis is needed to determine the best course of action for the LCHA and its residents. Additionally, there are plans to replace the roofing on all 3 developments, pending the receipt of funding.

Due to a lack of affordable housing options, there is a great demand for public housing units and housing choice vouchers. This has resulted in a significant waiting list for both types of housing, which is regularly closed. The Public Housing waitlists opens one (1) time per year for a two (2) week period. During this two (2) week period, it is likely that over 2000 names will be placed on the waitlists. Waitlists are monitored throughout the year to ensure they are opened as often as needed.

The Housing Authority of the City of Fort Myers' (HACFM) affiliate, Southwest Florida Affordable Housing Choice Foundation (SWFLAHCF) Inc. has converted its 142 NSP units to Project Based Voucher units. This will allow a larger clientele base creating more housing opportunities to not only the Very Low Income clients but also to the Extremely Low Income clients whose income falls at or below 30% of the AMI.

HACFM added an additional 72 units to its inventory stock at The Homes at Renaissance Preserve, which completes the projects development.

HACFM continues to promote a safe living environment for all residents. HACFM continues to partner and works with the local police department to add enhanced security at all properties. HACFM will add several security enhancements to Southward Village, a public housing development with 200 units. Such enhancements include but are not limited to added security lighting, high definition cameras, road closures to create a one way in and one way out of the development and the installation of a guardrail on the outer perimeter of the development. HACFM and Fort Myers Police Department (FMPD) are working to open a Police Substation at Southward Village, The Landings at East Pointe, and The Homes at Renaissance Preserve.

Lee County Human and Veteran Services is actively coordinating with HACFM and LCHA regarding the

lease up emergency housing vouchers (EHV) that were provided as a result of the American Rescue Plan.

Actions to encourage public housing residents to become more involved in management and participate in homeownership

Public Housing residents have the benefit of voluntary participation in the LCHA Family Self Sufficiency program, which provides one-on-one counseling and guidance in the areas of employment, secondary education, credit counseling, and homeownership counseling. LCHA also plans to implement a Homeownership program which would allocate a percentage of our Housing Choice Vouchers to be used to subsidize mortgages for our qualified HCV participants. The Housing Authority of the City of Fort Myers has active tenant associations at three of the public housing properties to encourage resident participation and involvement.

If the PHA is designated as troubled, describe the manner in which financial assistance will be provided or other assistance

HACFM and LCHA are high performing agencies in both Public Housing and Section 8. Neither is designated as troubled.

AP-65 Homeless and Other Special Needs Activities – 91.220(i)

Describe the jurisdictions one-year goals and actions for reducing and ending homelessness including

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

Increasing the number of outreach staff to engage, asses and refer persons experiencing the lack of housing to services that would assist them with permanent housing solutions.

Funding provided as a result of the Covid-19 pandemic was used to significantly enhance street outreach and coordinated entry services. Street outreach efforts were expanded through the implementation of Housing Outreach and Treatment Teams. Many Continuum's of Care (CoC) across the U.S., leverage partnerships with local law enforcement agencies to conduct street outreach to persons who are experiencing homelessness. This effort, often referred to as Homeless Outreach Teams or HOT Teams, has many models.

In Lee County, HOT teams are referred to a Housing, Outreach, and Treatment Teams to encapsulate the scope of services being provided. These teams are possible through collaboration between Lee County, Centerstone, and local law enforcement, including Lee County Sherriff's Office, Cape Coral Police Department, Fort Myers Police Department, Sanibel Police Department, Lee County Port Authority and Florida Gulf Coast University Police Department.

Lee County's HOT Teams consist of a law enforcement officer and behavioral health professional. Teams conduct street outreach to persons experiencing homelessness, with the main goal of connecting individuals and families to housing and services. HOT Teams conduct assessments, provide referrals for housing and shelter, and connect households with behavioral health and other supportive services.

In addition, Coordinated Entry services, which aim to connect individuals and families to permanent housing resources were expanded to be available 24 hours per day, 7 days per week through a partnership with Center for Progress and Excellent, the local behavioral health agency which also operates the Mobile Crisis Unit. This partnership provides connections to housing and also crisis assessment outside of regular business hours.

Addressing the emergency shelter and transitional housing needs of homeless persons

The provision of emergency shelter at the Bob Janes Triage Center and Low Demand Shelter helps to address some of the needs of individuals who are homeless. The HOME Tenant Based Rental Assistance program also supports the housing needs of individuals and families who are homeless, by providing a permanent housing solution instead of emergency shelter. As additional funding sources become available, Lee County may engage other community partners for the development of additional projects

or programs. Emergency shelter and transitional housing needs may also be addressed through grant funding opportunities, such as the competitive Continuum of Care process, and through other state or local funding streams.

Lee County uses the coordinated entry process to prioritize those who are most vulnerable. Implement more low-barrier practices to assist with ease of entry. Several non-profit organizations and Lee County Human and Veteran Services have rapid rehousing projects that engage and assess the needs of program participants and responding with wrap around services. Such services include connection to training, employment search, behavioral health services, etc.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

The plan's goals of providing homeless housing and services will help to prevent homelessness, rehouse, or otherwise permanently house persons who are homeless. The Lee County Continuum of Care has established written standards for prioritization to ensure that persons with especially high needs are linked with adequate housing and supportive services. Additionally, the implementation of the coordinated entry process ensures that persons who are homeless are rapidly linked with appropriate housing resources and support. Ongoing collaboration between service providers and the Continuum of Care, and frequent reviews of HMIS data facilitate the implementation of strategies to reduce the length of time a person experiences homelessness.

These goals will be supported through the use of ESG funding which is used to engage and rapidly rehouse persons who are homeless. Other than the funds available through this process, permanent housing needs may be addressed through other resources identified elsewhere in this plan, and through other grant funding opportunities, such as the competitive Continuum of Care process, and through other state or local funding streams.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); or, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs.

Human and Veteran Services and other local agencies provide many programs and services aimed at preventing homelessness and stabilizing clients. These programs include job training, job readiness, Annual Action Plan

financial management courses, and active case management. Several homelessness prevention programs active throughout the County provide assistance with rent and utilities to ensure that persons who are extremely low-income do not become homeless. These programs have streamlined the application, assistance, and referral process for persons who are homeless by participating in the coordinated entry process implemented by the Continuum of Care.

In addition, discharge-planning agreements are in place with the local foster care agency, mental health and substance abuse provider, jail, and hospital. These agencies refer clients to appropriate service and housing providers to ensure that they are not discharged into homelessness. Agency communication and cross sector planning are crucial to ensuring wrap around services are provided effectively.

AP-75 Barriers to affordable housing – 91.220(j)

Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment

At this time, there are no identified public policies that create barriers to affordable housing. Lee County recently implemented affordable housing incentives as part of the 2017-2020 Local Housing Assistance Plan in an effort to encourage the development of additional affordable housing. Lee County continues to invest NSP program income to create additional affordable housing through the rehabilitation and sale of foreclosed homes to eligible homebuyers.

In addition, quarterly reports are collected from regional partners to evaluate the actions taken toward addressing barriers to fair housing, as noted in the Analysis of Impediments. Actions taken toward eliminating these barriers will include providing accessibility and modifications in housing units. Lee County has collaborated with other local governments and the public housing authorities to update the Analysis of Impediments to Fair Housing Choice (AI). The updated AI is attached to Lee County's 2019-2023 Consolidated Plan.

Advocacy and education, as well as meeting with elected officials.

AP-85 Other Actions – 91.220(k)

Actions planned to address obstacles to meeting underserved needs

Lee County, in coordination with other local service providers, plans to undertake the projects and associated activities, as noted in this plan, to address underserved needs such as substandard housing conditions, public services, infrastructure, and non-profit capital improvements. Projects and activities such as these are not anticipated to encounter obstacles during completion. Public comments indicate a significant need for additional affordable housing units. Lee County intends to undertake multiple projects to facilitate the development of additional affordable housing units. Obstacles to these projects may include limited availability of units to be acquired or rehabilitated, and limited resources available to complete projects. Lee County will ensure that identified units are suitable for affordable housing development through underwriting, and coordination with community partners and other county departments, as required.

Objective 135.1 of the Lee Plan (http://www.leegov.com/dcd/planning/leeplan) states that the County will work with private and public housing providers to ensure that the additional dwellings needed by 2025 are provided in types, costs, and locations to meet the needs of the Lee County population. To meet this objective, policies have been adopted that including one to eliminate excessive or duplicative regulatory requirements.

Lee County created a committee with the responsibility to review and consider the impact on the cost of development by regulations being considered for adoption. On October 6, 1993, the Board of County Commissioners created the Executive Regulatory Oversight Committee (EROC) to consider all such regulations or amendments.

Other Lee Plan Policies that support this objective include ones that provide technical assistance and incentives to the private sector to maintain housing production. Policies that encourage the formation of public-private partnerships to produce housing for very-low, low and moderate-income households. Ones that allow bonus density to stimulate the construction of very-low and moderate income housing. Policies that provide for expedited permitting, payment waiver or reduction of impact fees, purchase of tax certificates for building lots and site preparation, and construction infrastructure in partnership with very-low, low and moderate income housing providers.

In addition to pursuing the policies identified above, the Board of County Commissioners has adopted the Local Housing Assistance Plan (LHAP) to implement the State Housing Initiative Partnership Program (SHIP). The LHAP includes an Incentive Report produced by the Affordable Housing Advisory Committee. The Incentive Report provides an analysis of current programs and recommendations to encourage the construction of affordable housing and help to mitigate any policies that may impact the availability of

affordable housing.

This includes:

- Expedited Permitting;
- Ongoing Review Process;
- Impact Fee Reimbursement Program;
- Impact Fee Exemption Program;
- Utility Connection Fees Deferral Program;
- The allowance of flexibility in densities for affordable housing;
- The allowance of affordable accessory residential units in residential zoning districts;
- The reduction of parking and setback requirements for affordable housing;
- The allowance of flexible lot configurations, including zero-lot-line configurations for affordable housing;
- The modification of street requirements for affordable housing;
- The preparation of an inventory of locally owned public lands suitable for affordable housing; and

The support of development near transportation hubs and major employment centers and mixed-use developments.

Actions planned to foster and maintain affordable housing

Actions planned include using CDBG, HOME, and state funds to provide owner occupied housing rehabilitation assistance and down payment assistance. In addition, HOME funds are being allocated for CHDO and Non-CHDO housing development to facilitate the development of additional affordable housing units. Lee County has implemented the HOPWA Tenant Based Rental Assistance Program (TBRA), which is projected to house about 10-15 of the most vulnerable HIV/AIDS households. Partnerships with the Public Housing Authorities and other local housing providers will provide additional resources to foster and maintain affordable housing through new construction, rehabilitation, and referral to currently available units.

Actions planned to reduce lead-based paint hazards

Homes built prior to 1978 where painted surfaces will be disturbed will be inspected for lead based paint. If lead is detected during the inspection, an assessment will be completed, followed by abatement.

Actions planned to reduce the number of poverty-level families

Lee County Human and Veteran Services supports anti-poverty programs of non-profit social service

Annual Action Plan 2021 agencies with county general funds through the Partnering for Results Program. Lee County has budgeted \$5,103,583, to support programs, which provide a variety of anti-poverty services in the following categories: Children & Youth Programs and other Supportive Living type services. All programs address issues to assist in reducing poverty and assisting low/moderate income households. Beginning 10/01/19, 53 programs were funded within 38 agencies in the following categories: 35 programs providing Children & Youth services and 18 providing Other/Supportive Living services.

Actions planned to develop institutional structure

Institutional structure is not deemed lacking. Gaps in providing programs or services that meet the priority needs will be evaluated on an annual basis, but at the onset of this planning cycle, there are no identified gaps to implementation. Continued coordination will help to ensure an effective institutional structure.

Actions planned to enhance coordination between public and private housing and social service agencies

Lee County works to bring together different groups and agencies, including private housing and social service agencies, when appropriate for both specific projects and for overall planning. In addition, the County works with local housing agencies to leverage resources to meet housing, infrastructure, and other service needs throughout the County. Human and Veteran Services is currently partnering with the Public Housing Authorities and local service providers to utilize existing and apply for additional HUD Mainstream Vouchers, which will facilitate enhanced collaboration among service providers.

The existing Lee County Policy and Procedure manual and CoC Written Standards and Coordinated Entry Policies will be used to outline standards for the ESG rapid re-housing project. CoC Written Standards and Coordinated Entry Policies are attached to this plan.

In general, eligibility will be determined prior to providing assistance. Applicants must have incomes at or below 50% of the area median income. Households must meet the HUD definition of homelessness under Category 1, any subsequent CoC Program Notice of Funding Availability (NOFA) eligibility requirements, and any additional funder eligibility requirements. Once meeting the rapid re-housing eligibility requirements, households are then prioritized by Lee County's target populations.

Income inclusions, income exclusions, and documentation standards can be found in the referenced manual. Verification and documentation of eligibility will be maintained in participant case files. Provided the requirements of each individual self-sufficiency plan are met, eligible households can receive 50 percent rent subsidies for six months. Exceptions may be made to the duration of assistance after management review and approval.

For the shelter operations component of ESG, standards for assistance will be detailed in the subrecipient provider contract and will stipulate eligible expenditures, beneficiary reporting requirements, and other procedural components of the program.

2. If the Continuum of Care has established centralized or coordinated assessment system that

meets HUD requirements, describe that centralized or coordinated assessment system.

The Coordinated Entry System has three goals

- 1) To help people move through the homeless service system faster,
- 2) Reduce new entries into homelessness through prevention and diversion resources, and
- 3) Improve data collection and quality to provide accurate information on what assistance consumers need.

The Lee County Continuum of Care (CoC) has developed a coordinated entry system, which uses the existing HMIS system. The process includes the use of a standardized assessment for all individuals, as well a coordinated referral and housing placement processes to ensure that people experiencing homelessness receive appropriate assistance with both immediate and long-term housing and service needs. In addition, monthly meetings are held to ensure especially high risk clients are linked with the appropriate services. Quarterly planning workshops with outreach workers and service providers are also held to obtain input on the design and help to secure buy-in for the system. Training for local agencies continues to be provided on an on-going basis as needed. The CoC Governing Board has reviewed and updated the Coordinated Entry Policies and Procedures in accordance with CPD Notice 17-01.

- 3. Identify the process for making sub-awards and describe how the ESG allocation available to private nonprofit organizations (including community and faith-based organizations).
 - Lee County has determined the programs to receive assistance and their allocations based on comments received by the public and in consultations during the planning process, as well as staff review of program success to date. A portion of the ESG allocation is provided to the Salvation Army support rapid-rehousing activities at the Bob Janes Triage Center and Low Demand Shelter.
- 4. If the jurisdiction is unable to meet the homeless participation requirement in 24 CFR 576.405(a), the jurisdiction must specify its plan for reaching out to and consulting with homeless or formerly homeless individuals in considering policies and funding decisions regarding facilities and services funded under ESG.

The requirement has been met.

5. Describe performance standards for evaluating ESG.

Overall evaluation of the ESG program will be undertaken by the Continuum of Care Governing Board. The Governing Board has established the following performance targets for all CoC and ESG funded projects:

- 1. 65% of persons in ES,SH, TH, or PH-RRH should be exited to permanent housing destinations
- 2. 45% of persons in CoC and ESG funded programs should maintain OR increase their income

3. No more than 35% of persons who were exited from CoC and ESG funded programs should return to homelessness within 1 year.

Performance standards may be evaluated on a project-by-project basis. At minimum, Lee County expects to assist 68 households through HOME and ESG funded re-housing activities. Success of these programs will be measured by examining the beneficiaries served and system performance measures.







III. Reports

A. Program Reports

1. COVID Response Update - Kim Hustad

Ms. Hustad mentioned the Department of Human and Veteran Services office is closed to the public and staff is prohibited face-to-face contact. Fifty percent are currently working remotely. We are strictly enforcing social distancing and wearing masks. The conference room has been converted to cubicles as additional staff was brought over from Lee Cares.

3. Homeless Prevention Report - Kim Hustad

Ms. Hustad mentioned since COVID started they received 2,024 applications, which does not include the backlog in the e-mail portal. They are moving to a different platform, which is easier to manage. So far, they assisted 424 household, 321 were denied as a result of not returning their documentation. Currently 150 are being reviewed and 450 are waiting to be reviewed.

4. CSBG Financial Report - Kim Hustad

Ms. Hustad said the report was not available at the time due to fiscal being overwhelmed.

ACTION:

Ms. Hustad said this CSBG Financial Report is tabled until the next meeting.

5. CoC Update - Mark Tesoro

Mark Tesoro introduced himself. He is the manager who oversees the Continuum of Care. They are currently working on the PIT Count. The PIT count is an annual activity they conduct at the end of January where they do an unsheltered and sheltered count. The unsheltered count is primarily done with volunteers and other staff that count individuals who are homeless. Due to COVID, things will have to be done differently with abbreviated interviews. They will be utilizing the HOT team and others to conduct the PIT count on January 27, 2021. The 100 by 100 project, which refers to housing 100 households in 100 days. Currently, they are in week 5 and were able to house 20 households. The Cold Weather Outreach program entails a coordinated effort with the Emergency Operations Center. When temperatures reach 40 degrees or colder, the outreach program is enacted. Information is pushed out to the individuals to let them know when and where they can obtain blankets and/or offer shelter.

Kerry Constantine said she understands the PIT Count is very important for funding for the county. She would like to know what the plan is to reach out to others besides downtown Fort Myers. She is referring to Cape Coral, Lehigh Acres, Bonita Springs and Fort Myers Beach. Mark Tesoro said due to COVID, it has been a challenge to get volunteers. The Department of Housing and Urban Development went from not allowing waivers and allowing waivers and recently saying if we did the PIT Count in 2020, you do not have to have a waiver at all. From the County's perspective, they will collect the information with an amended survey. Jeannic Sutton mentioned in the past they have gone to service locations at Fort Myers Beach, Lehigh Acres and Bonita Springs. Ms. Wick mentioned she has toiletries and asked would this be items she could give to Human and Veteran Services. Mark Tesoro stated yes they could use them. Discussion took place regarding Cold Weather Outreach. Mark Tesoro mentioned when they are on site they offer blankets, coffee, blankets and transportation to shelters or the Bob Janes Triage Center. Some homeless individuals do not want to leave their camp, or may have had a bad experience with the shelter or triage. Ms. Hustad stated the Salvation Army Resource Center is open to homeless individuals. They can utilize laundry, showering, mental health resources and much more. Question was asked about law enforcement being involved with the homeless. Jeannie Sutton said law enforcement have designated their own team. They are still bringing members onto their teams.

Ms. Dennehey asked does the committee have input or ideas where CDBG funding should be spent. Someone asked about a timeline. Clare Dennehey said this will be submitted in the early fall of 2021 and will go into place effective October 2021. Kerry Constantine suggested the need to focus on affordable and transition housing. All comments will be summarized and submitted with the plan for consideration. Suggestion was made for emergency transitional housing. Ms. Sutton said the Bob Janes Triage Center has respite unit beds for those that are medically needy and individuals in wheelchairs are able to go as long as they can self-transfer. Suggestion to have additional respite unit beds available at the Triage Center.

Ms. Dennehey inquired about infrastructure, job training or youth programs. She wanted to know what aspects are important in the community such as job training, education, such as afterschool programs. Suggestion was made for assistance with addictions and drug prevention. Ms. Dennehey stated assistance with additions and drug prevention is not an eligible expense. Ms. Sutton said the expense for public services is approximately 15% maximum, which can be utilized for public services. She did elaborate the County funds behavioral services through general fund dollars in the amount of \$4 million.

Ms. Keesha Wick mentioned child care is needed especially with COVID. Question was asked could additional funding for additional housing units be utilized. The funding is expended very quickly and the formula is allocated by the State. It was mentioned by a committee member that the funding is not enough to meet the needs of the community. Ms. Dennehey asked what approach would help to obtain housing. Committee member mentioned when a client has an eviction notice, it is too late to ask for rental assistance and possibly revamp??? the program. Ms. Sutton stated the regulations stipulate they have to have an eviction notice especially with the COVID relief package.

Mr. Charles Garretson asked why property could not be purchased to build tiny houses before they individuals are evicted. Ms. Dennehey will look into it further.

B. CDBG CARES Act 2 Application - Clare Dennehy

All the programs and projects have to be in response to prevent or prepare for COVID. Some eligible activities include:

- Building activities
- Assistance to businesses
- Job Training
- Delivering meals on wheels
- Installation of wiring for internet access
- > Planning
- Foreclosure and eviction prevention

II. Public Comment

Ms. Clare Dennehy presented the Annual (HUD) Housing and Urban Development allocations. Community Development Block Grant (CDBG). HOME and Emergency Shelter Grant (ESG) entitlement amounts for FY 2021 program year. The money will be allocated this fall. The total a CDBG allocation amount is \$3.2 million, HOME is \$1 million and ESG is \$275,000. Some project possibilities:

- Acquisition of real property
- > Public facilities and improvements
- Clearance
- Public services
- > Privately owned utility installation
- Housing construction by CBDO
- > Code Enforcement
- > Special economic activities
- Down payment Assistance
- > Program Administration

Activities currently that are run through CDBG are public facilities and improvements, public services, rehabilitation and admin. Previously discussed at the meetings were economic development, job training in the community, mentorship youth program, affordable housing needs and transportation.

Ms. Kirsten O'Donnell mentioned affordable housing, work force housing would be a valuable investment either for construction or down payment assistance.

Activities with HOME funding can be utilized for new construction, owner or renter occupied housing, rehabilitation, down payment assistance, tenant based rental assistance and program administration.

Some eligible activities for ESG are street outreach, homelessness prevention, homeless shelter renovations and rapid rehousing.

Mr. Garretson said that he thought that was a pretty good plan.

Ms. Dennehy stated should anyone have additional comments, please let her know.

III. Reports

A. Program Reports

1. Continuum of Care (CoC Update) - Mark Tesoro

Mr. Tesoro stated he is the manager for the Homeless Impact Program. On December 1, 2020 the CoC took on the challenge of housing 100 households in 100 days. Rapid rehousing has exceed the goal with 115 households housed. This translates to 186 individuals with 60 of those who were children. The NOFA was submitted for approximately \$700,000 for street outreach and non-congregate shelter. They are in the process of reviewing application received. The Performance Evaluation and Ranking Committee (PERC) is reviewing the criteria for projects to be funded. The Rapid Transition Collaborative plan was submitted to the City of Fort Myers Council for review.

The outreach team from our office, the HOT teams and Centerstone are out in the field daily to see what the needs are and try to provide housing for them.

Ms. Hustad introduced Ms. Nicole Turner with the Procurement Department for Lee County. Their department is assisting households facing homelessness or housing instability due to the inability to pay rent or utilities as a result of the COVID-19 pandemic.

2. Emergency Rental Assistance (ERA) - Nicole Turner

Ms. Nicole Turner gave an overview of the program. The program is specifically for households that are renting and have an active lease, impacted by COVID-19 and at or below the medium income. The parameters, although strict, they have flexibility with working with individuals. They are assisting with up to 6 months of past due rent and perspective rental. They have received 2,000 applications and have arrearages paying March, April and May. The client has to recertify every 3 months with another full application. Once they recertify they can assist with another 3 months with a maximum of 12 months. The client can receive assistance with rent, water and electric. The client can apply online at https://leeflcares.com/ website. The website has a tool for clients to determine if their property is located within city limits. The City of Fort Myers has their own program, so the client must apply with them.

Ms. Kerry Constantine would like to know how many individuals are on the list and is there a waiting list. Ms. Turner said there are many applications are in the process, which is approximately 2,800. Approximately 2,000 have been fully completed and 500 to 600 have started being reviewed. Cases have been prioritized based on a number of factors. Households with the lowest income under 50% area medium income regardless of chronological order. Also, households that has COVID related unemployment for the past 90 days or more are prioritized. It is a point based system. Ms. Constantine asked how many individuals may not be served and when will the funding run out. Ms. Turner stated they have \$20 million and wants to help as many individuals as they can and not concerned about running out of money.

3. Homeless Prevention Report - Kim Hustad

Ms. Hustad mentioned since COVID started, 1,227 applications were received. Since January 2021, 116 were served. They still have 772 applications. Of the 772, 47 have eviction notices and 35 are homeless. If someone indicates they are homeless have income and identified housing they are assigned to a processor every morning to house them. There are 26 on the list that have a lease that are not being renewed, there are 123 with past due mortgage, 331 with past due rent that do not have a direct COVID loss of income. There are 82 with past due water and 165 are being process and 85 have been referred to the ERA program. Ms. Hustad mentioned they converted from an excel spreadsheet to a new electronic platform. When a client applies on line, it automatically is placed on the electronic Smartsheet.

4. Community Services Block Grant Financial Report (CSBG) - Kim Hustad

Ms. Hustad reviewed the Community Services Block Grant Financial report. The report reflects the month of January 2021 with \$43,188.83 being spent. Ms. Hustad said there are 3 CSBG budgets and there is an allocation specifically for COVID.

Ms. Hustad reported the Department of Economic Development has put an umbrella agreement for CSBG and LIHEAP (Low Income Home Energy Assistance Program). This agreement goes before the Board of County Commissioners on Tuesday, March 16, 2021.

Ms. Keesha Wick mentioned the calls United Way receives, the client is applying for electric assistance utilizing the Homeless Prevention Application. Ms. Wick will redirect them to the appropriate program.

Annual Homeless Count Estimates 2,789 Homeless in Lee County Media Contact: Janet Bartos, Executive Director, Lee County Homeless Coalition (239) 322-6600

The Lee County Homeless Coalition is an advocacy group made up of individual stakeholders and agencies who are engaged to ensure that homelessness is rare, brief, and one-time. The Coalition represents the Continuum of Care, a local planning body that coordinates housing and human services funding for homeless families and individuals. Once per year the Coalition, with the help of many volunteers, conducts a Point in Time (PIT) census to count the homeless and provide data to the U.S. Department of Housing and Urban Development (HUD). The PIT count is also used to gather the information that allows local service providers to target services to meet the specific needs of the homeless in our communities.

The PIT count, which asked people where they slept the night of January 26, 2021, included both sheltered and unsheltered homeless individuals and families. The PIT count documented 394 homeless persons, of whom fifty-seven (14.47%) were chronically homeless according to the HUD definition. HUD defines chronic homelessness as "an unaccompanied adult homeless individual with a disabling condition who has either continuously been homeless for a year or more or has had at least four episodes of homelessness in the past three years." Among the 394 homeless persons surveyed, 29.44% percent reported having a disabling condition. Also, among the 394 were thirty families with sixty-five children. There were 39 veterans recorded in the PIT count, 35 of which were active in a Rapid Rehousing program working with a case manager to obtain housing. Data obtained through the Lee County Homeless Management Information System (HMIS) and PIT count found that during the year, there were an estimated 2,789 people experiencing homelessness in Lee County.

Housing and service programs for the homeless are provided in part through Continuum of Care funds from HUD. The 2020 Continuum of Care funding announcements were made in January 2021. Lee County was awarded funding to sustain existing programs and begin new programs that provide housing and services to persons experiencing homelessness. These programs are operated by Lee County Human and Veterans Services, Community Assisted and Supported Living, Lee County Housing Development Corporation, Jewish Family and Children Services, Saint Vincent de Paul, Goodwill Industries of SWFL, and The Salvation Army. The total awarded amount was \$1,997,727.

The Lee County Homeless Coalition would like to extend a special thank you to the volunteers that assisted with this year's PIT count.
