1. ACTION REQUESTED/PURPOSE:

- (A) Approve award of Formal Quotation No. Q-110171 Annual Purchase of Ford Automobiles, Sport Utility Vehicles, Passenger & Light Duty Vans, Light & Medium Duty Trucks, and Cab & Chassis for the Division of Fleet Management, to Sam Galloway Ford the sole quoter (a local vendor) offering the best discount off the "Dealer Selling Price" Column of the Karpower on Line new car Kelly Blue Book pricing software.
- (B) Board approval is also requested for the use of Option "A" for the installation of Dealer Installed Options.
- (C) The initial term of this quote is one year; also request authority to renew this quote for four additional one-year periods, at the same terms and conditions, if in the best interest of Lee County. While vehicle purchases have declined in the recent past, the county over the last five years has averaged approximately \$1, 248,120.00 annually for the purchase of vehicles. Funding will be available from the individual department or division's budget whom will be responsible for monitoring their individual expenditures.

Funds for this contract will be available from various different department/division accounts as vehicle needs arise.

3. WHAT ACTION ACCOMPLISHES:

This purchase will allow Fleet Management to provide various departments with reliable vehicles with which to perform a variety of County work functions. Fleet Management will be able to replace aging units, which are fully depreciated and increasingly unreliable, with new units capable of meeting the arduous demands of the various County departments/divisions.
