The activity will allocate funds for the implementation of case management and resource navigation for persons who were impacted by Hurricane Ian.

- o The subrecipient for these funds will be Catholic Charities. This subrecipient was selected through a NOFA process in February 2023.

- o Catholic Charities is lead organization for Lee County's Unmet Needs Long Term Recovery Group. An Unmet Needs Long-term Recovery Group is made up of faith-based, nonprofit, community-based, private sector, and voluntary agencies, who have a shared goal to help affected families access resources for their recovery.

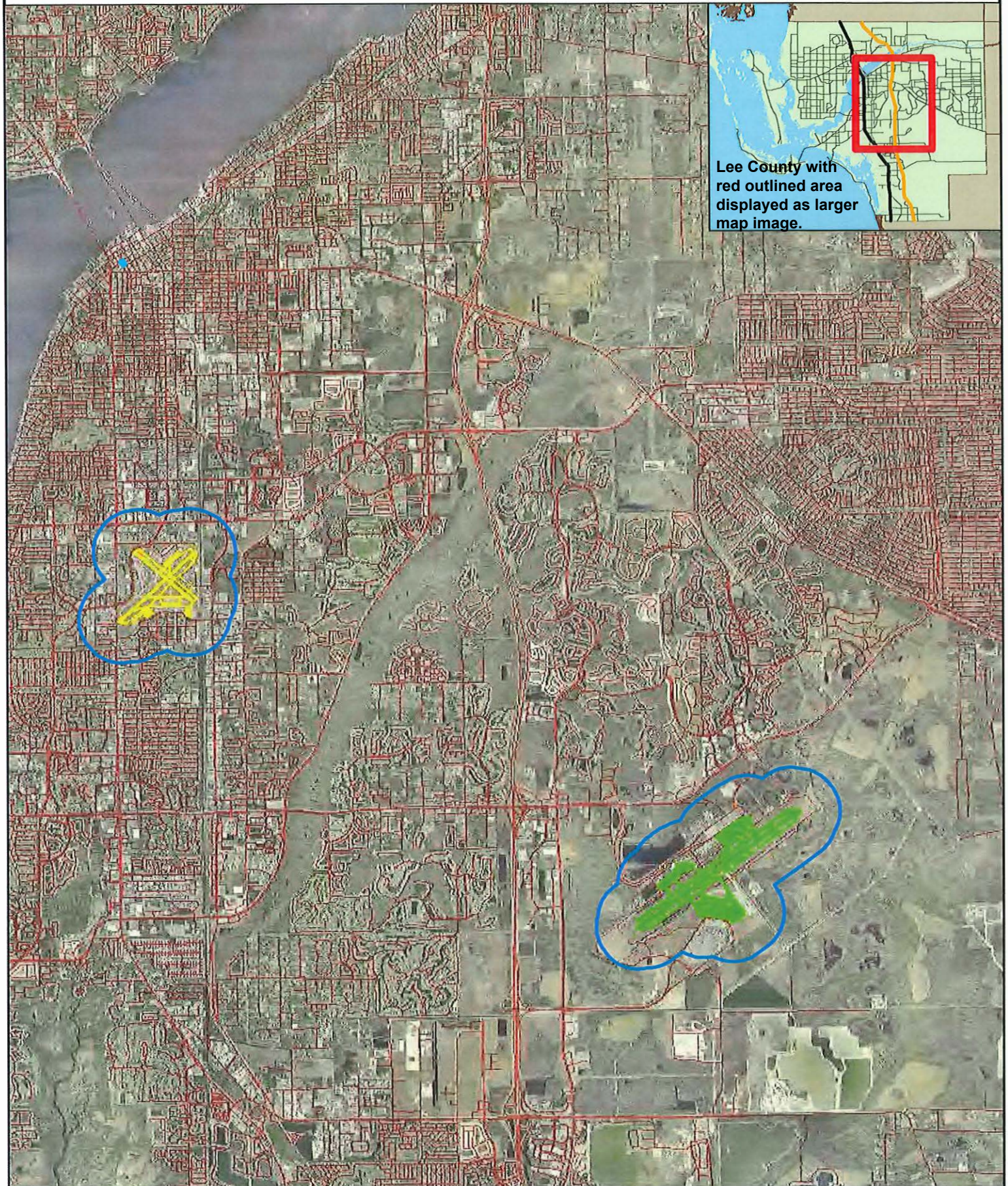

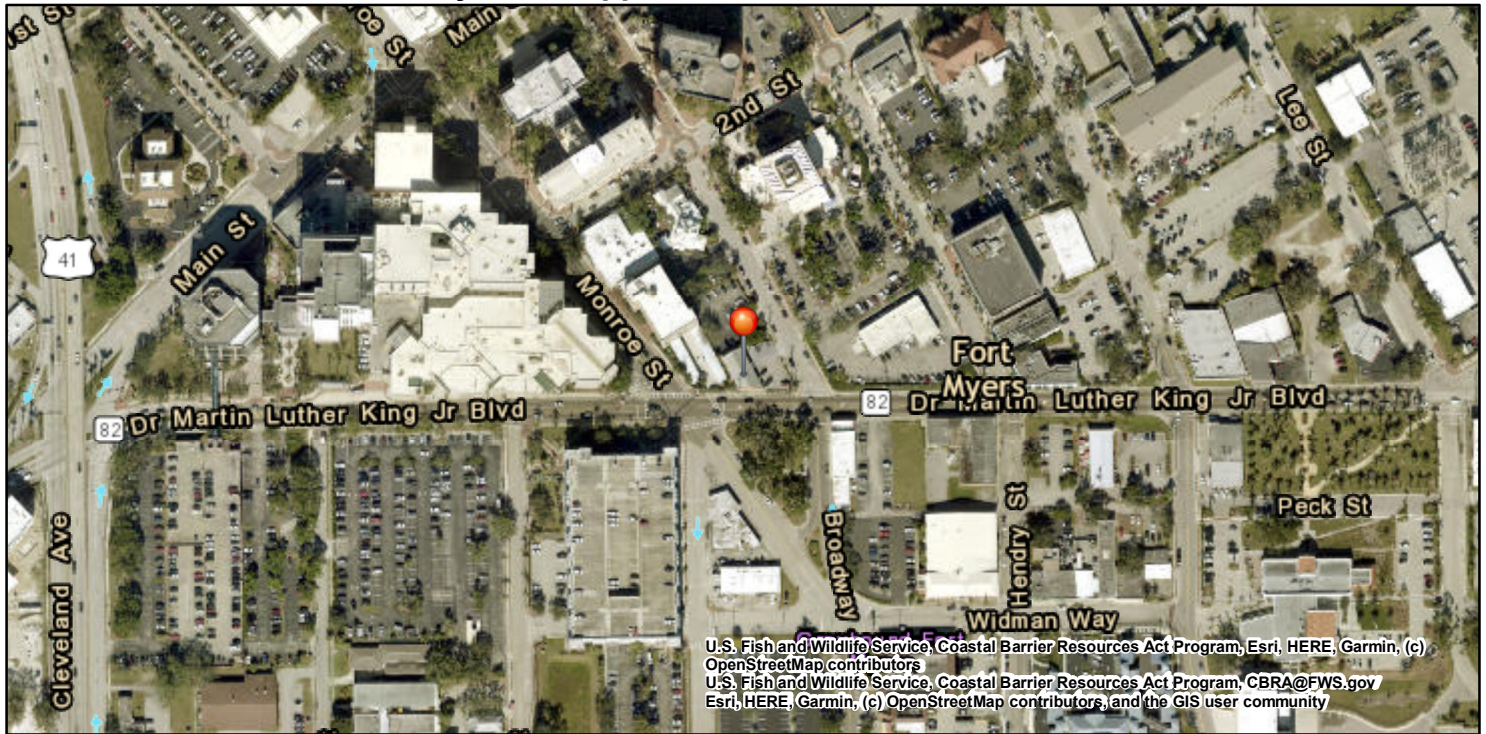

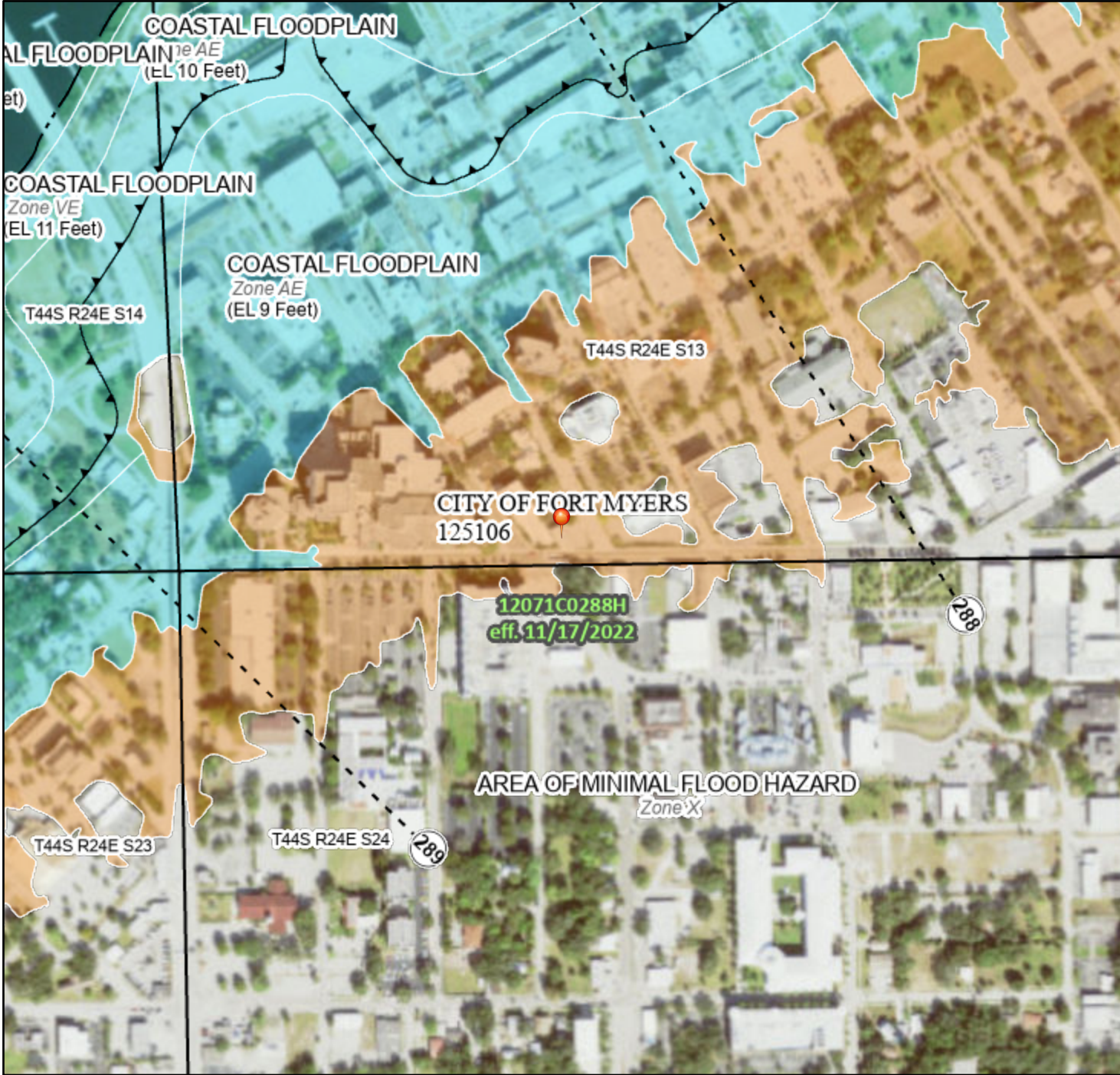
